His Chicago theatrical credits include offloop productions as Thomas in "Maria's Secret" and as Chris in "All My Sons."

Dan moved to New York City, where he completed a two-year program at the William Esper Studio, working extensively with Suzanne Esper. He has also studied with and been directed by Angie Montalbano (casting director, NYC) and Jack Pogi (theatrical actor, director and professor at Columbia University, NYC). He appeared as a detective on "All My Children" and as an attorney on the television series "Damages".

Dan now lives in the Bay Area and has studied with and has performed for Shari Carlson at the Shari Carlson Studio in San Francisco.
